**2010 YOUTH EXCHANGE CONVENTION RULES  
OHIO-ERIE YOUTH EXCHANGE CONVENTION**

Otterbein College, Westerville, Ohio  
July 9, 10 & 11, 2010

1. I understand and will abide by the rule that boys and girls will be hosted on separate floors or dorms, and I agree that boys will not enter girls' floors or dorms and girls will not enter boys' floors or dorms at any time day or night. I understand that I, along with all the other boys or girls, may meet in the designated lounge areas during approved hours.
  2. I will be prompt for all meetings.
  3. I will observe and abide by the program schedule with regard to residence hall closing and lights out. **TRESPASSING ANYWHERE ON THE OTTERBEIN COLLEGE CAMPUS AFTER THE FACILITIES CLOSING HOURS IS STRICTLY FORBIDDEN BY THE COLLEGE'S RULES AND OUR CONTRACT WITH THEM.**
  4. I agree that I (Outbounds, Inbounds, Rebounds) will remain on the campus of Otterbein College during the entire convention and that I will not drive from the time that I check in until the time that I check out. I understand that this means that I will not leave the campus to go into the town of Westerville or elsewhere in the Columbus area. I understand that permission to arrive at the convention late or to leave early must be granted prior to the convention by **both my District Chair AND the Ohio-Erie Chair.**
  5. I will attend all sessions and meetings listed for my category (Outbound, Inbound, Rebound) on the program schedule.
  6. I am under 21 years of age. At my age I know that the use of alcoholic beverages and or illegal drugs is a criminal offense in the State of Ohio and the City of Westerville and if I am a Rebound over the age of 21 I understand that such consumption is not permitted anywhere or at any time on the campus of Otterbein College or the City of Westerville.
  7. If I am under the age of 18 years of age, I know that use of tobacco products is a criminal offense in the State of Ohio and the City of Westerville and I will not use them. If I am over the age of 18 and either an Outbound or Inbound student participating in this exchange program, I agree to abide by the same tobacco product rules that apply to those participants who are under the age of 18. If I am a Rebounder over the age of 18, I agree to abide by the College's ban on smoking in all buildings at all times.
  8. Before the end of the weekend convention I will evaluate my intentions and goals in becoming an exchange student. If I have any misgivings or concerns I will discuss them with my Country Contact and District Chairperson before I leave Otterbein on Sunday morning.
